

## PREVENT RISK ASSESSMENT- EXTREMISM AND RADICALISATION

This risk assessment is a core part of the Prevent Duty and has been completed alongside the school’s extremism and radicalisation audit. All staff and Governors should read [Protecting children from radicalisation: the prevent duty](#). It is a statutory requirement our schools assesses the risk of children being drawn into terrorism, including support for extremist ideas that are part of terrorist ideology. The purpose of this risk assessment is to have an awareness and understanding of the risk of radicalisation in our school.

### Key Definitions

**Radicalisation** is defined as the process by which people come to support terrorism and extremism and, in some cases, to then participate in terrorist groups.

“**Extremism** is vocal or active opposition to fundamental British values, including democracy, the rule of law, individual liberty and mutual respect and tolerance of different faiths and beliefs. We also include in our definition of extremism calls for the death of members of our armed forces, whether in this country or overseas” (HM Government Prevent Strategy 2011)

Since the publication of the **Prevent Strategy**, there has been an awareness of the specific need to safeguard children, pupils and families from violent extremism. There have been attempts to radicalise vulnerable children and pupils to hold extreme views including views justifying political, religious, sexist or racist violence, or to steer them into a rigid and narrow ideology that is intolerant of diversity and leaves them vulnerable to future radicalisation.

## The Northamptonshire Context & Priorities

### Context:

- Referrals into Northamptonshire Prevent 2022 increased by 12% on the previous year. Referrals have trebled since 2019.
- Highest volume of referrals in November, March and May - 70% from education and policing sectors. Schools have referred the highest number (47=39%), an increase of 15% on the previous CTLP report.
- Highest rates of referrals are individuals aged 12-16 (42% of total referrals / 13% increase on 2021).
- Within this age group, 52% of cases have no ideology or vulnerabilities present, 38% have an established ideology and 10% Mixed/Unclear/Unstable ideology.
- 55% of referrals received into Northamptonshire Prevent relate to minors, 16% young adults and 29% adults.
- Males are the dominant gender referred, this is also reflected in regional and national referral figures.
- Female referrals remain on par (2% decrease on last year). All females referred are under 30, most in the 12-16 age group.

### Local Priorities: The Counter Terrorism Local Priorities for 2023 in Northamptonshire are:

- The threat posed by **Online extremism** is high with 35% of Northamptonshire's investigations involving the World Wide Web. This is 2.5% higher than last year and is likely to be higher due to the after-effects of Covid 19
- **Extreme Right Wing** is an ongoing issue in the Northamptonshire area, with 16% of 2022 investigations involving this thematic area. This is a 54% reduction in investigations compared to 2021.
- **Islamist extremism** continues to pose a threat and features heavily in Northamptonshire's investigations in this CTLP period, with 61% of the investigations reflecting this thematic area.
- Responses from the CTLP survey report the highest **emerging areas as; ERW/Racial hate crime, community tensions** followed by refugees settling in the Northants area.
